The Buddy Walk® was developed by the National Down Syndrome Society in 1995 to celebrate Down Syndrome Awareness Month in October and to promote acceptance and inclusion of people with Down syndrome. The Buddy Walk has grown from 17 walks in 1995 to nearly 300 walks planned for 2021 worldwide. In 2016, more than \$14 million was raised nationwide to benefit local programs and services, as well as the national advocacy and public awareness initiatives of NDSS that benefit all individuals with Down syndrome. The 2021 Brattleboro Buddy Walk will include many special activities including a one mile walk in which anyone can participate without special training and everyone is welcome. Proceeds for this year's walk will go to "Special Olympics of VT" programs in Windham County.
